#### WHAT IS A TRUSTFF?

The Charities Act 1993 defines 'charity trustees' as those legally responsible for the running of the charity, for its property, finances, employees, participants and volunteers. Ultimately ensuring that it is solvent, well-run, and delivering the charitable outcomes for which it has been set up. All Trustees serve as volunteers and receive no payment for their work.
